






Skilled Nursing

We staff highly qualified registered nurses & licensed practical nurses. Available up to weekly for:

Home Health Aid

Available up to 2 x weekly for:

- Perform and document a client's vital signs
- Medication reminders
- Simple dressing change
- Assist with ADL's includingbathing, bowel & bladder care, skin care, oral hygiene, grooming, ambulation
- Assist with Active and Passive ROM
- Perform Meal Preparation: prepare meal, serve meals, prepare next meal, assist with feeding, encourage fluids.
- General Housekeeping duties may include, but is not limited to: cleaning bathroom, washing dishes, changing linens, laundry, and emptying trash.

Personal Care Assistant

Available to hire upon request if patient has their own caregiver available who is qualified per DHS guidelines. Services provided may include:

- Perform and document a client's vital signs
- Assist with ADL's includingbathing, bowel & bladder care, skin care, oral hygiene, grooming, ambulation
- Assist with Active and Passive ROM
- Perform Meal Preparation: prepare meal, serve meals, prepare next meal, assist with feeding, encourage
- General Housekeeping duties may include, but is not limited to: cleaning bathroom, washing dishes, changing linens, laundry, and emptying trash.

Homemaker

Available up to 5 hours weekly. Also able to hire upon request if patient has their own homemaker who meets requirements. Services provises may include:

- Cleaning areas of the clients bathroom, bedroom, kitchen including:
- Sweeping, vacuuming & washing floors
- Cleaning and dusting surfaces.
- Washing dishes, sinks, refrigerator, stoves & toilets
- Providing laundry care including changing bed linens
- Meal preparation
- Trash removal

Language Assistive and Auxillary Aid Services

Equity Services of St. Paul will provide language assistance and auxillary aid services for individuals with limited English proficiency or disabilities (including individuals' companions with limited English proficiency) to ensure effective communication and access to our services.
